Advance Family Pass Purchase - Additional Information

- **Advance Family Pass Donations**
 - **\$20 per Family Pass** – Use for Canada Day or Practically Canada Day
 - **\$30** – Use for both Practically Canada Day June 30th and Canada Day July 1st
 - Donations Support Rotary Club of Guelph community funded projects
- **Companies, Organizations & Individuals can purchase multiple Family Passes**
 - Individuals purchasing individual or multiple Advance Family Pass purchases can receive a Charitable Tax Receipt for the net proceeds¹ of their donation amount
 - Companies and Organization Family Pass Purchasers receive a business receipt for their donation and can be recognized for their Family Pass donation on our Website and the contributions are included in our sponsor recognition package
 - You can provide the opportunity and encourage new Canadians and/or income challenged families to participate in the Canada Day celebrations by donating family passes to these groups² – if you would like to support this initiative please email familypass@canadayinthepark.ca or call 519 823 3846. *Our target contribution is 500 passes*
- **Advance Family Pass Donations can be purchased by:**
 - credit card payment with passes delivered On-Line
 - e-transfer or cheque with passes delivered via email
- Family Passes will be delivered by email on receipt of payment
- **A Valid email is mandatory for ticket and receipt and pass delivery in all cases.**
- **Details of payment and recognition** instructions are on the website
- Family Pass Donation holders **must** present their pass at one of the entry gates at Riverside Park - Advance Family Pass holders will **not** be asked for a donation request free entry at the gate.
- **Non-Advance Pass Holders entering the park will be asked for a donation at the gate.**
- **Family Definition** – Typically 2 adults and attendant school age children or any combination of up to 5 members typically 1-3 adults and or 1-4 children.

1. Login to your online banking website and select Interac e-Transfer
2. Add a new recipient – Rotary Club of Guelph Fundraising Account
3. Email: irsca3@gmail.com

- “Family Pass 2019” with number of \$20 & \$30 passes purchased or number of
- Individual Donor Name or Your Business / Organization Name
- Email Address to forward the Passes & Receipts – **Mandatory Requirement**
- # Passes to be donated to deserving families by Rotary – If any

3. Please ensure that your contact name, email, and phone # are added in the subsequent request questions – **a valid email is mandatory to receive passes**
4. Complete Credit Card Payment
5. Your Family Passes will be delivered by email

Paying by Cheque - Please complete sponsor confirmation form and make cheques payable to Rotary Club of Guelph “Family Pass” and forward to P.O. Box 511, Guelph, ON, N1H 6K9

For Individuals
